Message from: Our Board Chair

During the 2024–2025 school year, LifeAct celebrated the 25th anniversary of our first Suicide Prevention program. In this annual report, I'm delighted to share our community outreach efforts, events, service impact, and gratitude to our partners—each a vital chapter in the story of how LifeAct continues to help youth find strength, resilience, and hope.

Guided by our mission—to prevent suicide by educating young people to recognize warning signs of depression and seek help for themselves and others—**LifeAct empowered and supported 55,431 middle and high school students last school year.** Our prevention-trained instructors connected nearly 5,000 of these students to school-based mental health support. This was an all-time service record for our organization, demonstrating both the demand for and trust in our mental health programming.

Thanks to the generosity of our individual donors, foundations, and corporate partners, LifeAct delivered our Suicide Prevention and Stress Management programs at no cost to 210 schools across 17 Ohio counties, removing financial barriers and ensuring equal access. Your investment continues to make a positive and immeasurable difference for those we serve.




TO ENSURE EQUAL ACCESS TO MENTAL HEALTH EDUCATION

TEACHING IMPACT

- 12 prevention-trained instructors (*certified by the Ohio Department of Mental Health and Addiction Services*) teach students to recognize signs of depression and suicide and how to seek help.
- In 2024–2025, instructors reported 4,948 students to school-based mental health resources.
- Report Rates for the Suicide Prevention Program* (% of students reported for follow-up):
 - Overall:** 11% (consistent with last year)
 - Middle school:** 15.5%
 - High school:** 7.5%
 - Highest report rate:** 53%

SERVING UNDER-RESOURCED SCHOOLS

- LifeAct reached a record number of schools with high Economically Disadvantaged (ED) rates.
- Among public and charter schools served:
 - 75% had ED rates above 30%
 - 34% had ED rates over 96%
 - 42 schools had 100% ED rates
- LifeAct targets lower-income schools because research suggests these young people are more likely to attempt suicide due to socioeconomic stressors.

ADULT PROGRAMMING (QPR)

- LifeAct is an authorized provider of **QPR Gatekeeper Training (Question, Persuade, Refer)** — a 60-minute, evidence-based program that teaches adults how to recognize and respond to suicide warning signs.
- In 2024–2025, LifeAct trained **696** adults from schools, libraries, churches, social service organizations, corporations, and municipal offices, and more.



Did You Know?

In Ohio, **one in three** students reported challenges with anxiety, and the number of high school students with major depressive episodes has nearly doubled over the past decade.

(Ohio Dept. of Education & Workforce, Aug. 2025)

Talking about suicide may reduce, rather than increase, suicidal ideation. If someone is in crisis or depressed, **asking if they are thinking about suicide can help.**



Ohio House Bill 123 requires public and charter schools to provide at least one class period of evidence-based instruction (for students in Grades 6–12) on suicide awareness, prevention, and more.

LifeAct's Suicide Prevention program satisfies this requirement at no cost to schools.




